Memorandum of Understanding Between

The Antelope Valley Community College District

And

The Antelope Valley College Federation of Teachers

This Memorandum of Understanding (MOU) is made as of the 18th day of November 2025 by and between the Antelope Valley College Federation of Teachers ("AVCFT") and the Antelope Valley Community College District ("DISTRICT"), collectively known as the "PARTIES." This MOU expires on December 31, 2025, or upon the return of Dean Dr. Wendy Stout from leave, whatever occurs first.

RECITALS

Whereas, the DISTRICT hired Athletic Director Joel Gunterman to serve as the Educational Administrator supervising all coaching staff and Intercollegiate Athletics (IATH) instructors. Athletic Director Gunterman assumed his position in April 2025.

Whereas, the DISTRICT transitioned instructional faculty in the departments of Health Education (HE), Kinesiology Fitness (KINF), Kinesiology Theory (KINT), and Recreational Leadership (REC) to report to the Dean, Health and Safety Sciences (HSS), Dr. Wendy Stout.

Whereas, Dr. Stout took an unexpected, emergency leave of absence effective October 1, 2025.

Whereas, the DISTRICT hired Dr. Vickie Mulvaney-Trask to serve as Acting Dean, Health and Safety Sciences from October 6, 2025, through October 31, 2025. Effective November 1, 2025, Athletic Director Gunterman will serve as the Acting Dean, Health and Safety Sciences and Athletic Director.

Whereas, the PARTIES have recognized the need to identify temporary substitutes for the supervising educational administrators serving on the evaluation committees for tenure-track, permanent, and adjunct faculty given Dr. Stout's absence.

Whereas, The PARTIES desire to work together to support the Evaluee and their committees to ensure an appropriate evaluation of their work performance.

IT IS NOW, THEREFORE, AGREED AS FOLLOWS:

- 1. Should the need for this Agreement extend beyond December 31, 2025, the PARTIES may mutually agree to modify this Agreement or portions thereof in writing.
- 2. The PARTIES agree that in the absence of Dean Stout, Acting Dean of Health and Safety Sciences, will serve as the Educational Administrator and supervisor for all faculty reporting to the Dean of Health and Safety Sciences.
- 3. The PARTIES agree that the Acting Dean and/or Dean of Math, Science,

and Engineering, Dr. Jedi Lobos will participate in the faculty evaluation processes during Dean Stout's absence and will draft the respective Dean's reports. The attached chart lists the faculty members under evaluation and the assigned evaluator.

- 4. The PARTIES agree that the future evaluation committee composition for faculty members in the tenure process will be reviewed and discussed as applicable prior to the start of the 2026-2027 academic year.
- 5. Unintended Consequences: Should an unforeseen issue arise, the AVCFT and the Vice President Academic Affairs will consult and come to a mutual agreement to resolve the issue.
- 6. Entire Agreement: This Agreement is non-precedential and constitutes the entire agreement and understanding between the PARTIES. There are no other oral understandings, terms or conditions. All prior understandings, terms, or conditions are deemed merged into this Agreement.
- 7. Execution: This Agreement may be executed in one or more counterparts, including by signature pages delivered in electronic format, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
